

REGISTRATION AND PARTICIPATION IN CONSTRUCTION IN POLAND 2019 - TERMS AND CONDITIONS

1. What follows are the Terms and Conditions for registration and participation in the **Construction in Poland 2019** conference (henceforth Conference) organised by PMR Sp. z o.o. (henceforth PMR) in Warsaw on **4 October 2018**
2. The following participation fees apply per person:
 - o **€895 + 23% VAT Special Fee* for the first 15 persons** who register by **31 January 2018** and pay the full amount within 14 days of receipt of the proforma invoice.
 - o **€995 + 23% VAT** for those who register by **30 April 2018** and pay the full amount within 14 days of receipt of the proforma invoice.
 - o **€1,095 + 23% VAT** for those who register by **30 June 2018** and pay the full amount within 14 days of receipt of the proforma invoice.
 - o **€1,195 + 23% VAT** for those who register **after 30 June 2018** or pay the full amount after 16 July 2018.

*** Only participants in previous Conference editions are eligible for the Special Fee.**

3. If two or more persons from the same company register at the same time, the company gets **€100 off the applicable fee for the second and each subsequent delegate**. (Note: the Special Fee cannot be discounted.)

 - o **€2,990 + 23% VAT** (STANDARD license)
5. The participation fee includes:

7. Payment of participation fees shall be made:
 - o **for those registering more than 30 days before the Conference** – based on a proforma invoice issued by PMR, by the date indicated on the invoice (and not later than within 14 days of the invoice issue date) to the bank account provided on the invoice. Upon receipt of the payment PMR will issue a prepayment invoice. A VAT invoice will be issued after the Conference. The value of the order and the price of the service will be expressed in PLN based on the euro's exchange rate to the zloty on the day before the proforma invoice issue date as announced by the NBP. The prepayment will be settled entirely in PLN.
 - o **for those registering less than 30 days before the Conference** – based on a VAT invoice issued by PMR, within 14 days of the invoice issue date, to the bank account provided on the invoice.
